Deadline for all Submissions – September 20, 2000, Postmark

The Southwestern Society of Economists (SSE) announces its annual meeting for February 28 – March 3, 2001 in New Orleans, to be held in association with the 28th annual meeting of the Southwestern Federation of Administrative Disciplines (SWFAD). You are invited and encouraged to attend and participate in this meeting by:

- Presenting a paper on any topic of interest to academicians in the economics discipline.
- Submitting a paper for the 2001 Distinguished Paper Award.
- Serving as a session chair and/or discussant.

For Program Participants:

1. Submit a 250 word abstract, together with the following: name, position, affiliation/university, address and telephone number and paper title. (Selection of your abstract obligates you to serve as session chair and/or discussant if needed).
2. Indicate the topic area of your paper.
3. Submit your name, position, affiliation/university, address and phone number by September 20, 2000 if you wish to serve as a session chair or discussant.

Conditions for Presentation:

1. Participants must register with both SWFAD and the SSE.
2. Presenters must mail copies of their paper assigned discussants and sessions chair.
3. Any person committing to present or discuss a paper is expected to do so. If a presenter or discussant has a legitimate reason for not

attending/presenting the paper at the scheduled time, he or she MUST notify the program chair in advance. Failure to notify the program chair in a timely manner may bar one from program participation at the SSE annual meeting for (1) year.

4. Any paper scheduled for the 2001 program that fails to comply with the above SSE policies may preclude its publication in the *Southwestern Economic Proceedings*.

For Submission to the Southwestern Economic Review:

Papers presented at the 2001 SSE annual meeting may be considered for publication in the *Southwestern Economic Review*. Abstracts will be published and available at the meeting. To be considered for publication in the *Review* specifications will be detailed in a separate mailing following the SSE meeting.

For the Distinguished Paper Competition:

Members of SSE are urged to submit papers for the 2001 Distinguished Paper Award sponsored by the Richard D. Irwin Publishing Company. The winner will receive recognition and a plaque from Irwin at the SWFAD's. The paper may be published in the *Southwestern Economic Review*.

Those who wish to enter this competition should submit five (5) BLIND copies of the paper and one (1) detachable cover page with the author's name, position, affiliation/university, complete address and telephone number. The paper must not be more than 25 pages in length including references. The paper must be postmarked no later than September 20, 2000.

All submissions and inquiries prior to the 2001 SSE meeting should be addressed to the Program Chairman. This information will also be mailed to all members of the SSE.

The Southwestern Society of Economists is accepting submissions for the 2001 issue of the *Southwestern Economic Review*. All papers dealing with economics-oriented topics and issues are welcome. The submitted manuscripts are refereed via a double-blind process.

Each submission is assessed a non-refundable fee of \$25 for members of the Southwestern Society of Economists and \$45 for non-members. All manuscripts must be submitted by September 20, 2000 to be considered for the 2001 issue.

Submissions of three *BLIND* copies of the paper with a detachable cover page with the author's name, position, affiliation/university, complete address, telephone, fax and e-mail and a 3.5" diskette should be sent to the address below. **MANUSCRIPT GUIDELINES FOR
SOUTHWESTERN ECONOMIC REVIEW
AND
SOUTHWESTERN ECONOMIC PROCEEDINGS**

SUBMISSION REQUIREMENTS

For the **Southwestern Economic Review**, three copies of the manuscript must be submitted under a separate cover page containing the manuscript title, the name, position, and institutional affiliation of each author. For the **Southwestern Economic Proceedings**, only one copy needs to be submitted.

FEES

- A) **Southwestern Economic Review** - There is a \$25 submission fee for all refereed papers submitted by members and a \$45 fee for non-members, the fee must accompany submission. **IN ADDITION**, if the paper is accepted for publication, there will be an additional fee of \$2 per page for the first five pages and \$15 per page thereafter.
- B) **Proceedings** - There is a \$10 submission fee. **ALL** articles in the proceedings are assessed fees of \$2 per page for each of the first five pages and \$15 per page thereafter. Fees must accompany submission.

FINAL MANUSCRIPT REQUIREMENTS

All manuscripts accepted for publication in the Review and Proceedings must be completed in WordPerfect 7.0 or Word 97 and submitted on a 3 ½ " diskette, and in hard copy on "STANDARD" 8 ½ x 11 white paper using letter-quality printer. Manuscripts may be e-mailed in the same form to the above e-mail address.

1. **Spacing and Type.** All manuscripts should be single-spaced and must be Times New Roman, size 10. Title should be both italics size 16 pt and names of the author and their institutions in italics size 11 font.

2. **Margins.** There should be one inch margin on all pages. The paragraphs should have a five-space indentation. Please do not number pages or use system generated page numbering.
3. **Title and Headings.** Manuscript titles should be left justified and bold in all capital letters. (1) First-level headings should be a triple space below text, left justified, bolded and in all capital letters with no numbers. (2) Second-level headings should be left justified, bolded and with only the first letter of main words capitalized. (3) Third-level headings should be at the left margin, underlined, first letter of main words capitalized. Double-space before all subheadings with a single-space after all subheadings.
4. **Abstract.** The abstract should appear three spaces below the title in a section entitled ABSTRACT. It should be no more than 100 words, which presents the principal substantive or theoretical points of the manuscript. No abstract is to be included in Proceedings publications.
5. **Tables, Figures, and Illustrations.**
Tables should be typed on separate pages with notations inserted in the manuscript such as [Tables 1 about here] and illustrations on separate pages. The headings should be bold with the main words capitalized. When composing tables, the t table format or the tab key are to be used in lieu of "spacing over." Tables should be typed in Times New Roman 8 pt font.
6. **Formulas.** Formulas should be single-spaced with two spaces below and above each formula. Each formula should have a number in parentheses on the right margin.
7. **Endnotes and References.** Endnotes should be used rather than footnotes. Do not use system generated foot notes. The endnotes should be consecutively numbered within the text and appear at the end, proceedings the references. All references to books, articles, monographs, etc., should be numbered and placed at the end of the manuscript, with a hanging indent in a section labeled References. They should be identified at the appropriate point in the text by using the number of the reference, e.g.: reference number 4, page 23 would be cited as [4, p.23]. For specific reference format, refer to The Chicago Manual of Style.
